## c) Other income/invoices received after agenda sent out – none 27.24 **PLANNING MATTERS** a) Planning Applications notified by Shropshire Council – none **b)** Planning Decisions – none c) Planning Correspondence or Decisions received after agenda sent out - none 28.24 **HIGHWAYS** a) Potholes - Discussions took place over the state of the roads in the parish, with concerns particularly over the deteriorating state of the highways, with numerous potholes that have been there for years, painted but not dealt with. RESOLVED that the Clerk should write to Andy Wilde (Assistant Director for Highways and Transport) to express the Parish Council's dissatisfaction. b) Drainage by Hordley Grange - Cllr Jones reported concerns regarding inadequate drainage by Hordley Grange, such that the road always floods when there is heavy rain leading to safety issues. He advised that he had reported the issue a number of times to Shropshire Council, suggesting that the drain be moved to a more suitable location. 29.24 FREEDOM FIBRE – new poles Proposals to install new poles in the parish were considered and concern was raised about three poles to be positioned directly outside the church. Cllr Beech advised that he had established that the telegraph poles opposite the church could be used, and he had then contacted Freedom Fibre to request that they use those existing poles or place the fibre underground. He was awaiting a response. It was RESOLVED that Cllr Beech should continue pursuing this with Freedom Fibre, and also speak to Shropshire Councl's Conservation Officer to make her aware of the concerns. 30.24 **POLICIES AND PROCEDURES** The following GDPR policies were reviewed and it was **RESOLVED** that no amendments were required: a) Privacy Policy b) Personal Data Management Policy & Audit Log c) Privacy Notice (basic & detailed) 31.24 **WEST MERCIA POLICE** The Town & Parish Council Survey 2024 was considered.
