She expressed frustration that ABP was permitted to expand which she believed to be totally inappropriate in the open countryside. Cllr Beech gave the background to the ABP Liaison Committee, explained that the parish council had fiercely opposed the expansion but that the parish council has no power over such matters and Shropshire Council is responsible. He advised of measures taken over the years to improve matters and of the speed mitigation measures currently being implemented and that he would take the resident's concerns to the next ABP Liaison Committee meeting. The resident asked to be advised of the response from ABP to her concerns.
